**CONDITIONS OF USE**

**Products to be used:**

**GARLON 600 HERBICIDE**

Containing 600 g/L TRICLOPYR AS THE BUTOXYETHYL ESTER as their only active constituent

**GRAZON DS HERBICIDE**

Containing 300 g/L TRICLOPYR PRESENT AS THE BUTOXYETHYL ESTER, 100g/L  
PICLORAM PRESENT AS THE HEXYLOXYPROPYLAMINE SALT

**GRAZON EXTRA HERBICIDE**

Containing 300 g/L TRICLOPYR PRESENT AS THE BUTOXYETHYL ESTER, 100g/L  
PICLORAM PRESENT AS THE HEXYLOXYPROPYLAMINE SALT and 8 g/L AMINOPYRALID  
PRESENT AS HEXYLOXYPROPYLAMINE SALT as its only active constituents.

PASTURES, RIGHTS OF WAY BUSHLANDS AGRICULTURAL NON-CROP AREAS	All species of the Cactaceae family	<b>Grazon DS Herbicide or Grazon Extra Herbicide</b> High Volume application 500mL in 100L of water plus 0.5% Uptake spray oil or Knapsack Application 50mL in 10L of water plus 50mL Uptake spray oil  <b>Garlon 600 Herbicide</b> 1L in 75L of diesel or High Volume application 3L in 100L of water plus 0.5% Uptake spray oil or Knapsack application 50mL in 10L of water plus 50mL Uptake spray oil.

**Critical Use Comments:**

- Do NOT allow spray to drift onto sensitive areas including, but not limited to, natural streams, rivers, wetlands or waterways and human dwellings.
- Apply to actively growing plants. Some retreatment may be necessary, particularly with large clumps.
- Knapsack - a spray volume of 3L to 4L per 10m<sup>2</sup> should be used.
- When mixing, follow the label directions. Add the Uptake last.
- Do not use Grazon DS in bushland areas or under trees.

**Jurisdiction:**

NSW only.

**Additional Conditions:**

This permit provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.
