FOR CONTROL OF WEEDS IN CHESTNUT AND PISTACHIO NUT CROPS

CONDITIONS OF USE

Products to be used:

SPRAY.SEED 250 HERBICIDE
AND OTHER REGISTERED PRODUCTS

Containing: 135 g/L PARAQUAT and 115 g/L DIQUAT as their only active constituents.

TRYQUAT 200 NON-RESIDUAL KNOCKDOWN HERBICIDE

Containing: 125 g/L PARAQUAT and 75 g/L DIQUAT as the only active constituents.

Directions for Use:

CHESTNUT (<i>Castanea spp.</i>)	ANNUAL BROADLEAF AND GRASS WEEDS AS PER CURRENT PRODUCT LABEL	<u>Spray.Seed 250 Herbicide</u> <i>High Volume Spray</i> Apply at a rate of 2.4 - 3.2 L product/ha
PISTACHIO NUT (<i>Pistacia vera</i>)		<i>Spot Spray</i> 240 - 320 mL product/100 L
CROPS		<u>Tryquat 200 Herbicide</u> <i>High Volume Spray</i> Apply at a rate of 3 - 4 L product/ha
		<i>Spot Spray</i> 300 - 400 mL product/100 L

Critical Use Comments:

Apply as required with directed spray only to come in contact with the soil and around the base of the trees.

The leaves and fruit should NOT be exposed to the spray. Use suitable nozzle type and shields around nozzles to minimise spray drift.

Use the higher rate for dense more established weeds.

May require addition of a wetting agent, use a directed.

Withholding Period:

Do not graze or cut sprayed vegetation for stock food for at least 1 day after application, or graze horses for 7 days after application. Remove stock from treated areas 3 days before slaughter.

Jurisdiction:

ACT, QLD, NSW, NT, SA, TAS, WA

(Note: Paraquat is a Schedule 7 Poison and a 'Restricted Use Chemical' under Victoria's control of use legislation. Restricted Use Chemicals must be used in accordance with the approved label unless a permit has been issued by the Victorian Department of Primary Industries. For further information please contact Chemical Standards Branch, DPI).

Additional Conditions:

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.
