FASTAC DUO INSECTICIDE (APVMA No. 51858)

PLUS ANY OTHER REGISTERED PRODUCTS

Containing: 100 g/L ALPHA-CYPERMETHRIN as the only active constituent.

CONQUEST ALPHA FORTE 250 SC INSECTICIDE (APVMA No. 65245)

PLUS ANY OTHER REGISTERED PRODUCTS

Containing: 250 g/L ALPHA-CYPERMETHRIN as the only active constituent.

Directions for Use:

Crop	Target pest	Rates
Potatoes	Garden weevil (<i>Phylctinus callosus</i>)	<u>100 g/L products:</u> 400mL/ha or <u>250 g/L products:</u> 160mL/ha

Critical Use Comments:

- Apply when adult weevils are present.
- Apply using boomspray.
- Use a spray volume of 100-600L per hectare.
- DO NOT use on crops where tubers are to be exported.
- DO NOT apply more than 3 applications per crop per season.

Withholding Period:

Harvest: Do not harvest for 14 days after application.

Grazing: Do not allow livestock to graze treated crops for 35 days after final application.

Jurisdiction:

WA & TAS only.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.
