TILT 250 EC FUNGICIDE (APVMA No. 62205)

PLUS OTHER REGISTERED PRODUCTS

Containing: 250 g/L PROPICONAZOLE as the only active constituent.

PROPIMAX FUNGICIDE (APVMA No. 59517)

PLUS OTHER REGISTERED PRODUCTS

Containing: 435 g/L PROPICONAZOLE as the only active constituent.

NUFARM THROTTLE 500 FUNGICIDE (APVMA No. 60401)

PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/L PROPICONAZOLE as the only active constituent.

Directions for Use:

Sweet Corn (<i>Zea mays var rugosa</i>)	Northern Corn Leaf Blight (<i>Excerohilum turcicum</i>)	<u>250 g/L product:</u> 500 mL/ha <u>435 g/L product:</u> 290 mL/ha <u>500 g/L product:</u> 250 mL/ha

Critical Use Comments:

- Apply when conditions are conducive to disease development.
- Apply by ground or aerial application.
- For ground application, add 3-5 L/ha of water-miscible oil to the spray mix. Use a convenient volume of water for the spray volume.
- For aerial application, add 3-5 L/ha of water miscible oil to the spray mix. Use a minimum spray volume of 30 L/ha of water.
- DO NOT apply more than 2 applications per crop.
- DO NOT apply less than 14 days after the initial treatment.
- Use a medium spray quality or larger according to the ASAE S572 definition for nozzles.

Withholding Period:

Harvest: Do not harvest for 28 days after application.

Grazing: Do not graze or cut for stock food for 28 days after application.

Jurisdiction:

ACT, NSW, QLD, SA, NT and WA only.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.
