Critical Use Comments:

Refer to the approved product label for critical comments, timing, frequency and method of application for Canola.

Crop sensitivity and tolerance:

The sensitivity and tolerance of Mustard (*Brassica juncea*) to products included under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.

Brassica juncea has shown sensitivity to clopyralid. Experience suggests that early application timing of herbicides containing clopyralid, at the 2-6 leaf stage of the crop, generally reduces the risk of potential crop damage.

Note those herbicides excluded from this permit refer to ‘**Products to be Used**’ above.

Withholding Period:

Adhere to all withholding periods and restrictions as detailed on approved product labels for products registered for use on Canola.

Jurisdiction:

ACT, NSW, SA, TAS, WA only.

(Note: Victoria is not included in this permit because their ‘control-of-use’ legislation means that a permit is not required to legalise this off-label use in VIC. However certain products used in Victoria require State approval. **For further information please contact the Victorian Chemical Standards Branch, DPI.**

Additional Conditions:

This permit provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.
