# PERMIT TO ALLOW SUPPLY AND MINOR USE OF AN UNREGISTERD VETERINARY CHEMICAL PRODUCT

This permit allows a Supplier (as indicated) to possess the product for the purposes of supply and to supply the product to a person who can use the product under permit. - 5. The supplier must immeditaely report any adverse experiences to the APVMA.
