## **Products to be used:**

DAVID GRAYS CHLORPYRIFOS 500 (APVMA No. 42284) NUFARM CHLORPYRIFOS 500 EC INSECTICIDE (APVMA No. 32902) PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/L CHLORPYRIFOS as the only active constituent.

#### **Directions for Use:**

Brassicas - Broccoli - Brussels Sprouts - Cabbage - Cauliflower	Vegetable Beetle (Adults) (Gonocephalum spp.)	5 kg prepared bait/ha

# **Critical Use Comments:**

# Bait Preparation:

Mix 40 mL product with 50 mL vegetable oil. Add mixture to 1 kg cracked wheat or sorghum and mix thoroughly. Gloves should be worn when preparing and applying baits.

# Monitoring:

Bait may be used to monitor pest presence before seeding or transplanting. Bait stations of approximately 3 cm in diameter may be placed equally across the field at a rate of 20 per hectare. Each station should be marked to enable relocation.

# Application:

Apply bait once near crop emergence or transplanting via a fertiliser spreader or similar applicator. Bait must remain on the surface.

DO NOT feed or expose treated bait to wildlife and domestic animals, particularly birds.

# Withholding Period:

Harvest: Not required when used as directed.

# **Jurisdiction:**

WA only.

## **Additional Conditions:**

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Continued issuance of this permit is subject to the outcomes of the current APVMA review of chlorpyrifos. This permit may be impacted by the outcomes of this review.
