Critical Use Comments:

- Minimum planting depth of 15 mm is required.
- Apply to a fine firm seed bed free of ridges, clods and trash within 2 days after sowing.
- Use the higher rate on heavier textured soils or those with higher organic matter content.
- Incorporate with 12 to 25 mm of spray irrigation within one day of the application for optimum performance. Irrigation is not required where adequate rainfall occurs immediately post-application.
- DO NOT disturb the soil by rolling or harrowing after application.
- DO NOT apply where heavy irrigation or rainfall is likely to lead to waterlogging.
- DO NOT use on soils with an organic matter content above 6% as inconsistent weed control will occur.
- Apply in accordance with label directions for carrots.

Withholding Period:

Not required when used as directed.

Jurisdiction:

ACT, NSW, QLD, SA, TAS, WA only.

Note: Victoria is not included in this permit as their *Control-of-Use* legislation does not require a permit to legalise this off-label use in that state.

Additional Conditions:

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.
