



PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

PERMIT NUMBER -PER6196

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows any person to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Product to be used:

STOMP 330E HERBICIDE OR ANY REGISTERED PRODUCT which contains 330 g/L PENDIMETHALIN as its only active constituent.

Directions for Use:

Crop	Pest	Rate
ADZUKI BEANS	BROAD LEAF WEEDS	2.5 to 3.0 L/ha

Critical Use Comments:

- DO NOT apply by air.
- Apply before planting.
- Incorporate within 24 hours, as per the product-label (Double incorporation or Incorporation by Sowing).
- DO NOT apply to a poorly prepared seed bed.

- DO NOT apply where water logging is likely to occur.
- DO NOT sow sensitive summer crops such as sorghum and millet within 12 months of application.

Withholding Period:

Not required when used as directed

Jurisdiction:

NSW, QLD.

Additional Conditions:

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use the products for the purposes specified in this permit must read, or have read to them, the permit particularly the information included in CONDITIONS OF USE.

TO AVOID CROP DAMAGE:

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.

EXPORT OF PRODUCE:

Exported produce or animals must have appropriate residue tolerance limits established in the importing countries and any residues must not exceed the tolerance limits.

APPROVAL ONTO A PRODUCT-LABEL:

Bona fide efforts to have this use approved onto a label must be made and adequately documented, during the currency of this permit. Such documentation must accompany any request for renewal of this permit. Note that any decision on renewal will depend on the efforts made and reasons for failure of those efforts.

THE PRODUCT is dangerous to fish and aquatic life. DO NOT Allow spray to drift onto sensitive areas including, but not limited to, natural streams, rivers, wetlands or waterways and human dwellings.
