

PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL

PRODUCT FOR CONTROL OF BEAN PODBORER AND BUDWORM IN BORLOTTI BEANS

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. Products to be used: LANNATE-L INSECTICIDE (APVMA No. 47336) PLUS OTHER REGISTERED PRODUCTS Containing: 225 g/L METHOMYL as the only active constituent.

Critical Use Comments:

- Apply when pests first appear. Repeat treatment depending on infestation.
- Apply using calibrated ground boom sprayer or similar equipment.
- Use sufficient spray volume to achieve good penetration and thorough coverage of foliage.
- Use higher rate on heavier infestations.
- DO NOT apply more than four (4) applications per crop per season with a minimum retreatment interval of 7 days between consecutive applications

Withholding Period:

Harvest: Do not harvest for 7 days after final application.

Jurisdiction:

NSW, QLD, NT and WA only.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Protection of livestock

Keep animals and unprotected persons out of operational areas during treatment and while there is any danger of drift. DANGEROUS TO BEES - DO NOT spray plants in flower while bees are foraging. Ensure beehives are removed from the area to be treated and from adjacent paddocks.
