This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

## CONDITIONS OF USE

### Products to be used:

COMITE MITICIDE (APVMA No. 51293)

PLUS OTHER REGISTERED PRODUCTS

Containing: 600 g/L PROPARGITE as the only active constituent.

OMITE 300W WETTABLE POWDER MITICIDE (APVMA No. 48086)

PLUS OTHER REGISTERED PRODUCTS

Containing: 300 g/kg PROPARGITE as the only active constituent.

### RESTRAINT:

DO NOT apply if rain is expected within 6 hours.

DO NOT apply using spraying equipment carried on the back of the user.

### Directions for Use:

Crop	Pest / Disease	Rate
Sweet Corn	Two-spotted mite ( <i>Tetranychus urticae</i> )	<u>600 g/L products</u> 2.5 L/ha  OR <u>300 g/kg products</u> 5.0 kg/ha

### Critical Use Comments:

- Apply before mite numbers reach economically damaging levels.
- Apply to foliage by ground boom spray or aerial application.
- Use a spray volume of 100 L/ha for ground application or 20 L/ha for aerial application.
- DO NOT apply more than 1 application per crop.
- Follow the re-entry requirements of the product being used.

### Withholding Period:

Harvest: Do not harvest for 4 weeks after application.

Grazing: Do not graze or cut for stock food for 4 weeks after application.

### Jurisdiction:

All States and Territories.

Note: The use of registered 300 g/kg propargite products in Victoria do not require this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

### Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

#### *To Avoid Crop Damage*

The sensitivity of the crop to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.

The holder of the permit must notify the APVMA of new information, including relevant information in accordance with section 161 of the Schedule to the Agricultural and Veterinary Chemicals Code Act 1994, in accordance with the obligation imposed by that section.
