## **Products to be used:**

BLADEX 900 WG HERBICIDE (APVMA No. 57850) PLUS OTHER REGISTERED PRODUCTS

Containing: 900 g/kg CYANAZINE as the only active constituent.

#### **Directions for Use:**

Crop Type	Target Weeds	Application Rate
SNOW PEAS SUGAR SNAP PEAS	Broadleaf weeds as listed on approved labels for peas and processing peas	1.1 or 2.2 kg/ha (TAS only)  1.1 kg/ha (ACT, NSW, NT, QLD, SA, WA only)

#### **Critical Use Comments:**

- Apply early post-emergence when weeds are in the young seedling stage.
- DO NOT apply more than one (1) application per crop.
- DO NOT use on sandy or loam soils as crop damage may result.
- DO NOT spray when dry conditions prevail.
- DO NOT apply to weeds or crops, which are stressed by dry or cold weather, waterlogging, disease or mechanical damage.
- DO NOT apply post-emergence in conditions of high humidity.
- DO NOT apply post-emergence if rain is likely within 8 hours.
- DO NOT use wetting agent with post-emergence applications.

## Withholding Period:

Harvest: DO NOT harvest for 28 days after application.

Grazing: DO NOT graze or cut for stock food.

# **Jurisdiction:**

ALL STATES except VIC.

Note: Victoria is not included in this permit, as their *Control-of-Use* legislation means a permit is not required to legalise this off-label use in that state.

#### **Additional Conditions:**

This permit provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.
