**PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL  
PRODUCT FOR CONTROL OF SCLEROTINIA ROT IN CELERY AND PEPPERS**

**PERMIT NUMBER – PER11127**

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

## CONDITIONS OF USE

### Products to be used:

FILAN FUNGICIDE (APVMA No. 56362)

PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/kg BOSCALID as the only active constituent.

### RESTRAINT:

DO NOT apply more than 4 boscalid applications to the same paddock per year, including paddocks which have been double cropped.

### Directions for Use:

Crop	Disease	Rate
Celery Peppers	Sclerotinia	0.8-1 kg/ha

### Critical Use Comments:

- Apply prior to disease development as a preventative measure and make a repeat application following an interval of 7 to 14 days.
- Use the higher rate and shorter interval when disease pressure is high.
- Apply in sufficient water to ensure complete and thorough coverage of foliage and/or crop.
- DO NOT apply more than 2 applications per crop.
- DO NOT apply less than 7 days after the previous treatment.

### Withholding Period:

Harvest:

Celery: Do not harvest for 14 days after application.

Peppers: Do not harvest for 3 days after application.

### Jurisdiction:

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

### Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

#### *To Avoid Crop Damage*

The sensitivity of the crop to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.

#### *Export of treated produce*

Maximum Residue Limits (MRLs) have been established to allow treated produce to be used for human consumption. MRLs have been established for BOSCALID in CELERY and FRUITING VEGETABLES, OTHER THAN CUCURBITS. MRLs can be found in the *Agricultural and Veterinary Chemicals Code (MRL Standard) Instrument 2019*. MRLs apply only to produce marketed and consumed in Australia. If treated produce is to be exported, residues must not exceed the limits/tolerances of the importing country.

*Other Matters*

The holder of the permit must notify the APVMA of new information, including relevant information in accordance with section 161 of the Schedule to the *Agricultural and Veterinary Chemicals Code Act 1994*, in accordance with the obligation imposed by that section.
