PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL

PRODUCT FOR PRESERVATION OF BEEKEEPING EQUIPMENT

PERMIT NUMBER – PER13026

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Products to be used: ARCH CN TIMBER OIL (APVMA No. 30700) PLUS OTHER REGISTERED PRODUCTS Containing: 20 g/L COPPER present as COPPER NAPHTHENATE as the only active constituent.

Directions for Use:

Critical Use Comments:

- Soak: Fully immerse (weighted down and spaced) in preservative solution for a minimum of 8 hours. Air for a minimum of 14 days until solvent has evaporated.
- Soak and wrap: Soak (as above) for a minimum of 1 hour and, while still wet, wrap tightly in plastic for a minimum of 3 days. Air for a minimum of 10 days until solvent has evaporated.
- Suitable solvents include most hydrocarbon solvents such as kerosene, thinners or mineral turpentine.
- DO NOT use treated timber without first painting with a food grade paint to prevent contact with bees. If using a water-based paint, treated timber must be primed appropriately.
- Observe all safety directions associated with both the product and the solvent selected for use dilution.

Withholding Period:

Not required when used as directed.

Additional safety directions:

Follow all safety directions on the product label. In addition, during treatment, wear chemical resistant gloves.

Rehandling:

If handling treated timber before the solvent has evaporated, wear chemical resistant gloves.

Disposal:

Dispose of used dip in an authorised dip disposal facility.

Jurisdiction:

All States and Territories.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.
