PRODUCT FOR THE CONTROL OF VARIOUS INSECT PESTS IN OLIVE
PLANTATIONS**

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

CONDITIONS OF USE

Products to be used:

NUFARM CHLORPYRIFOS 500 EC INSECTICIDE (APVMA No. 32902)

PLUS OTHER REGISTERED PRODUCTS

Containing: 500 g/L CHLORPYRIFOS as the only active constituent.

Directions for Use:

Crop	Pest	Rate
Olives	Ants African Black Beetle Light Brown Apple Moth	100 mL / 100 L

Critical Use Comments:

Ants

- Apply as a ground and butt treatment using 1000 L of spray mixture/ha to ground beneath trees, and 1.5 L per butt applied to lower butts.
- DO NOT apply more than two applications per season to trees that are of fruit-bearing age.

African Black Beetle

- Apply as a soil drench around the base of the tree.
- DO NOT apply more than two applications per season to trees that are of fruit bearing age.

Light Brown Apple Moth (LBAM)

- Apply as a foliar spray to non-fruit bearing trees only.

Withholding Periods:

Harvest:

Ground and Butt treatments (Ants and African black beetle): NOT REQUIRED WHEN USED AS DIRECTED.

Foliar applications (LBAM): Only apply to non-fruit bearing trees and DO NOT APPLY WITHIN 12 MONTHS OF HARVEST.

Grazing: DO NOT GRAZE OR CUT TREATED AREAS FOR STOCKFEED.

Jurisdiction:

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Export of Treated Produce:

Temporary Maximum Residue Limits (TMRLs) have been established to allow treated produce to be used for human consumption. An MRL has been established for Chlorpyrifos in Olives. MRLs can be found in the *Agricultural and Veterinary Chemicals Code (MRL Standard) Instrument 2019*. MRLs apply only to produce marketed and consumed in Australia. If treated produce is to be exported, residues must not exceed the limits/tolerances of the importing country.

Other Matters

Continued issuance of this permit is subject to the outcomes of the current APVMA review of chlorpyrifos. This permit may be impacted by the outcomes of this review.
