

PERMIT TO ALLOW MINOR USE OF AN AGVET CHEMICAL PRODUCT

TO CONTROL MIMOSA BUSH IN NONCROP SITUATIONS

PERMIT NUMBER - PER14929

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. Product to be used:

LONTREL HERBICIDE (APVMA No. 31635) PLUS OTHER REGISTERED PRODUCTS

Containing: 300 g/L CLOPYRALID PRESENT AS THE TRIISOPROPANOLAMINE SALT as the only active constituent.

LONTREL ADVANCED HERBICIDE (APVMA No. 65587)

PLUS OTHER REGISTERED PRODUCTS

Containing: 600 g/L CLOPYRALID PRESENT AS THE DIMETHYLAMMONIUM SALT as the only active constituent.

Critical Use Comments:

- Add 0.1% of a non-ionic surfactant, such as BS1000 or its equivalent.
- Apply as a high volume spray. Full coverage of shrub is essential.
- Apply to actively growing shrubs in full leaf.

CAUTION: CLOVERS AND MEDICS WILL BE ELIMINATED FOR AT LEAST ONE YEAR:

Re-establishment of legumes in treated pasture may take 12 months.

Refer to the label (Protection of Crops) for restrictions in following crops: plant back period may be up to 12 months, or even 2 years for very susceptible crops (e.g. field peas).

TREATED VEGETATION MUST NOT BE USED FOR THE PRODUCTION OF COMPOST OR MULCHES.

Withholding Period:

DO NOT GRAZE TREATED AREAS, OR CUT FOR STOCK-FEED, FOR 7 DAYS AFTER APPLICATION.

Jurisdiction:

NSW, QLD, NT and SA only.

Additional Conditions:

This PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use the products for the purposes specified in this permit must read, or have read to them, the permit particularly the information included in DETAILS and CONDITIONS of the permit.

TO AVOID CROP DAMAGE:

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.
