AND ALL OTHER REGISTERED PRODUCTS

Containing: 400 g/L PHOSPHOROUS ACID as their only active constituent.

NUFARM PHOSTROL 500 SYSTEMIC FUNGICIDE (67983)

AND ALL OTHER REGISTERED PRODUCTS

Containing: 500 g/L PHOSPHOROUS ACID as their only active constituent.

AGRI-FOS 600 SYSTEMIC FUNGICIDE (54430)

AND ALL OTHER REGISTERED PRODUCTS

Containing: 600 g/L PHOSPHOROUS ACID as their only active constituent.

AGRI-FOS 625 SYSTEMIC FUNGICIDE (61691)

AND ALL OTHER REGISTERED PRODUCTS

Containing: 625 g/L PHOSPHOROUS ACID as their only active constituent.

Critical Use Comments:

- Apply when conditions favour disease development using sufficient spray volume to ensure thorough coverage of the crop.
- For seedling/transplants up to 6 weeks, use lower rate after seedling emergence or transplanting; increase to higher rate when more established.
- Maximum 4 applications per crop, with minimum of 7 days between consecutive applications.

Withholding Period:

Harvest: DO NOT harvest for 1 DAY after final application.

Jurisdiction:

ALL States (except Victoria)

(Note: Victoria is not included in this permit because their 'control-of-use' legislation means that a permit is not required to legalise this off-label use in Victoria).

Additional Conditions:

THIS PERMIT provides for the use of a product in a manner other than specified on the approved label of the product. Unless otherwise stated in this permit, the use of the product must be in accordance with instructions on its label.

PERSONS who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit.

TO AVOID CROP DAMAGE:

The sensitivity of some species and varieties of the crops to be treated under this permit has not been fully evaluated. It is advisable, therefore, to only treat a small number of plants to ascertain their reaction before treating the whole crop.
