**PERMIT TO ALLOW MINOR USE OF AN UNREGISTERED AGVET CHEMICAL
PRODUCT FOR CONTROL OF EUROPEAN WASP**

PERMIT NUMBER – PER89402

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to possess the product for the purposes of use and to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

Persons who can use the product under this permit:

Licensed pest controllers, government and local council employees, and primary producers who are suitably qualified and are experienced in the application of agricultural chemicals.

CONDITIONS OF USE

Product to be used:

An UNREGISTERED BAIT prepared by combining:

MONARCH 100 INSECTICIDE (APVMA No. 84556)
PLUS OTHER REGISTERED LIQUID CONCENTRATE PRODUCTS
Containing: 100 g/L FIPRONIL as the only active constituent.

OR

REGENT 200SC INSECTICIDE (APVMA No. 46793)
PLUS OTHER REGISTERED LIQUID CONCENTRATE PRODUCTS
Containing: 200 g/L FIPRONIL as the only active constituent.

AND

20 g of meat substrate.

Directions for Use:

Situation	Pest	Rate
Vineyards, horticultural crops, public parks and reserves, outside eating areas and residential areas	EUROPEAN WASP (<i>Vespula germanica</i>)	20 g meat bait per bait station (Containing: 0.02 g Fipronil per 20g bait)

Critical comments:

- Baits must only be used when European wasp nest cannot be located or reached.
- Pre-baiting with blank (untreated) baits must be performed before using Fipronil-treated baits.
- Baiting with Fipronil baits can only be carried out if blank baits attract at least ten (10) European wasps in ten (10) minutes.
- If native species are at risk, treated baits must not be used until a location can be found that precludes native species.

Jurisdiction:

Tasmania only.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

Preparation and storage of baits

- Persons preparing baits must use the personal protective equipment described on the approved product label.
- Prepared meat baits must be packaged in an impervious sealed container labelled with the label at **Attachment 1**.
- During storage and transportation, prepared baits must be kept in a secure refrigerator.

Users:

- Use of the product in urban residential areas is restricted to licensed Pest Control Operators and government/local council employees trained for this use.
- Packaged meat baits must be opened in a well-ventilated area. Wear PVC gloves when handling and placing the prepared baits into traps. Wash hands after use.

Bait stations:

- Bait stations must be labelled with the label at **Attachment 2**.
- Bait stations must be used and must be of a design which will effectively retain the bait and prevent access to the bait of non-target animals. The permit holder can provide advice on bait station construction.
- The bait must be placed in a position where risks to non-target species are minimal and spillage of treated bait will not occur due to wind or other environmental factors.
- Hang bait stations using string or other material in areas out of reach of children and animals.
- Keep baits free of ant infestation. If ants are observed on baits during the blank pre-baiting period, bait stations should be moved to another location.

Completion of baiting program:

- Upon completion of the baiting program, no bait may be left at any of the treated locations.
- Users must remove any remaining bait and bait stations and dispose of any unused bait in the manner described on the label at **Attachments 1 and 2** to ensure negligible exposure to people and non-target animals.

Adverse effects:

The APVMA is to be immediately notified of any illness or injury suffered by any person and/or any untoward or adverse effect on the environment as a result of:

- having the product in possession or custody; and/or
- preparation for use and/or use of the product.

Record keeping:

Users are required to maintain records of all treatments performed under this permit (including pre-baiting). Details must include the date and locations where baits were placed, total amount of product used and the names and addresses of the persons undertaking the use. These details must be maintained for a minimum period of two years from the date of expiry of this permit and must be made available to the APVMA upon request.

Other matters:

Continued issuance of this permit is subject to the outcomes of the current APVMA review of Fipronil. This permit may be impacted by the outcomes of this review.
