

PERMIT TO ALLOW MINOR USE OF A REGISTERED AGVET CHEMICAL PRODUCT FOR CONTROL OF SARCOPTIC MANGE IN WOMBATS

PERMIT NUMBER – PER89982

This permit is issued to the Permit Holder in response to an application granted by the APVMA under section 112 of the Agvet Codes of the jurisdictions set out below. This permit allows a person, as stipulated below, to use the product in the manner specified in this permit in the designated jurisdictions. This permit also allows the Permit Holder and any person stipulated below to claim that the product can be used in the manner specified in this permit.

Persons who can use the product under this permit:

The Product must only be used by persons who have appropriate experience in classifying stages of mange infection in wombats and observation of toxicity signs.

CONDITIONS OF USE

Products to be used:

CYDECTIN POUR-ON FOR CATTLE AND RED DEER (APVMA No. 45970) PLUS OTHER REGISTERED PRODUCTS

Containing: 5 g/L MOXIDECTIN as the only active constituent and 150 g/L HYDROCARBON LIQUID as the only labelled solvent.

RESTRAINTS:

DO NOT use in conjunction with any other treatments.

Directions for Use:

Host	Pest	Rate
Wombats	Sarcoptic mange (Sarcoptes scabei)	0.8ml per kg body weight (maximum dose of 20mL on an adult wombat) Once weekly for 15 weeks, delivered via a burrow flap or direct application with a pole & scoop to the wombat's back.

Critical Use Comments:

- The Product must only be used by persons who have appropriate experience in classifying stages of mange infection in wombats and observation of toxicity signs.
- Treatment in wombats which show toxicity signs after the first treatment should be stopped immediately or the dose should be reduced in consultation with a registered veterinarian.
- Any wombats that die after treatment must be reported to a veterinarian immediately and a detailed post mortem should be carried out.
- Wombats with visible lacerations along the backline must not be treated with the Product.
- Due to the lipophilic nature of moxidectin and the lower proportion of body fat carried by wombats, an acute (immediate) poisoning effect is more likely to be seen in a wombat than chronic (long term) poisoning by repeated dosing over a long period. Do not overdose animals.
- The Product may be decanted in smaller containers (no larger than 1L poison bottles with a child proof lid.) that must be labelled in accordance with **Attachment 1**. The product must only be supplied as part of a wombat mange treatment kit.
- Where the treaters decant into 1 L bottles, the decanted amount must be used within 1 treatment cycle (15 weeks) in 1-2 wombats.
- DO NOT supply in drink bottles.

If poisoning occurs, contact a doctor or Poisons Information Centre. Phone 13 11 26.

Safety Directions:

Poisonous if swallowed. Will irritate eyes and skin. Avoid contact with eyes and skin. Wash hands after use. Do not inhale. May irritate the nose and throat.

Jurisdiction:

All States and Territories.

Additional Conditions:

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

The holder of the permit must notify the APVMA of new information, including relevant information in accordance with section 161 of the Schedule to the *Agricultural and Veterinary Chemicals Code Act 1994*, in accordance with the obligation imposed by that section.

Reporting Adverse Experiences:

The Permit Holder must record any adverse experience associated with the use of the Product that they are made aware of and report them to the APVMA's Adverse Experience Reporting Program (Ph 1800 700 583) as soon as possible. This includes reporting of any wombats which die after treatment.

Supply

The supplier must supply the product in a container that complies with the requirements of section 18 of the Agricultural and Veterinary Chemicals Code Regulations. Attached to this container must be a label which is identical in content and format to the label at **Attachment 1**.

The Product must only be supplied as part of a wombat mange treatment kit, which must include: the approved label particulars, a printout of the sign the text in **Attachment 2** and instructions on its placement, a copy of this permit, and the directions for use as set out in this permit.

WOMBAT MANGE TREATMENT

A wombat with mange lives in this area.

The wombat is being treated using a treatment that is applied to its skin via a burrow flap device or directly to its back via a pole and scoop (APVMA Permit 89982).

If you see this wombat, please stay away from it.

WARNING: Do not touch or interfere with the burrow flap device

The burrow device contains: 5g/L Moxidectin as the active, and 150 g/L Hydrocarbon Liquid solvent.

Safety Directions:

Poisonous if swallowed. Will irritate eyes and skin. Avoid contact with eyes and skin. Wash hands after use. Do not inhale. May irritate the nose and throat.
