#### **Products to be used:**

AGADOR TURF NEMATICIDE AND MITICIDE (APVMA No. 66380) PLUS OTHER REGISTERED PRODUCTS

Containing: 20 g/L ABAMECTIN as the only active constituent.

#### **Directions of Use:**

## **Critical Use Comments:**

- Follow all label recommendations and restrictions.
- DO NOT apply more than (3) three applications per crop per year with a minimum retreatment interval of 14 days.
- Apply in early curative situation (after nematode identification and counts).
- Use coarse droplets in a sufficient spray volume to evenly cover the soil surface, e.g. 1000 L/ha. Irrigate with 3-6 mm of water within 1 hour of application.
- Apply as a soil drench using a hand lance sprayer, spray boom or equivalent.
- DO NOT apply using spraying equipment carried on the back of the user.
- DO NOT apply to waterlogged soils.
- DO NOT apply if heavy rains or storms that are likely to cause runoff are forecast within 3 days.
- DO NOT irrigate to the point of runoff for at least 3 days after application.

## **Jurisdiction:**

All States and Territories, except VIC.

Note: Victoria is not included in this permit, as their Control-of-Use legislation means a permit is not required to legalise this off-label use in that State.

## **Additional Conditions:**

This permit allows for the use of a product in a manner specified on the permit. Persons who wish to prepare for use and/or use products for the purposes specified in this permit must read, or have read to them, the details and conditions of this permit. Unless otherwise stated, the use of the product must be in accordance with the product label.

## To Avoid Crop Damage

The sensitivity of the crops to be treated under this permit has not been fully evaluated. It is advisable to only treat a small area to ascertain the reaction before treating the whole crop.
